Myra Stearns

- AARC Leadership Conference was held in Dallas, TX and attended by Myra. She reported that the conference was more collaborative this year and that membership was the number one issue. Other issues addressed included:

  - New website will be up this summer with a younger theme

- 3. Secretary's Report

- March 7,2014
  - Minutes approved with corrections
  - Correct spelling of Pat Daley and Myra Stearns names.
- 4. Treasurer's Report

Travis Houston

- Assets and Equity as of 5/7/14: \$48,163.74
- ➤ Majority of revenue YTD is from revenue sharing (\$6,150.00)
- Expenditures for the year through May 7, 2014 are \$9,006.64
- > An additional expenditure of approximately \$1,000.00 will be due once webpage is completed.
- CD was renewed for 2 years at 0.595% which is 0.1% higher than reported at the March BOD meeting, The CD will renew on April 24, 2016.
- Fourth Quarter 2013 revenue sharing was \$2,866.50.
- First Quarter 2014 revenue sharing was \$6,150.
- 2013 taxes have been filed and accepted.

- The Budget and Audit Committee presented a recommendation that only the President, President Elect/Past President and Treasurer need full access to Paypal including access to transfer money out of the account. Other individuals requiring access to Paypal would have limited access with ability only to deposit money into the account. Limited access would be granted to the Public Relations (Merchandising) Committee Chair and Communications/Publications Chair.
- Motion Bowen and seconded by Connie Paladenech to accept the recommendation of the Budget and Audit Committee. Motion carried.
- The Budget and Audit Committee also presented the recommendation that the Executive Secretary be allowed to use the NCSRC credit card after approval from the President and/or Treasurer for required items for the annual symposium and phone minutes. The committee also recommends that a \$250.00 pre-paid credit card be issued to the Executive Secretary for last minute symposium miscellaneous purchases (receipts to be forwarded to Treasurer for budgeting/accounting purposes).

  The Bylaws and Standing Rules committee was charged by President Stearns to draft language to be included in the Standing Rules for this change.
- > A proposal was presented on NCSRC website advertising as stated in the May 2014 Budget and Audit Committee report.
- > A motion was made by Wayne Trainor and seconded by Christy Eisenhower to accept the Budget and Audit Committee's recommendations. Motion carried.
- > Travis Houston will research and report back at the September BOD meeting as to whether there is merit to changing NCSRC's tax status from 501 C3 to 501 C6 status as was discussed at the AARC Leadership meeting.

#### 12. Political Advocacy (Professional Standards)

**Lawson Millner** 

- 1,033 letters were sent through Capitol Connection by NCSRC members this year placing North Carolina in sixth place, overall, behind Florida in first place.
- ➤ HR 2619 has 31 co-sponsors including one Republican but none from North Carolina. The bill continues to sit in committee.
- NC PAC representatives Tim King, Lawson Millner and Susan Renaldo Gallo met with sixteen legislative contacts at Day on the Hill to ask for their support of HR 2619.
- Political Advocacy is being moved to the new website. Please submit pictures that can be rotated on the homepage to Lawson.
- NCSRC has not published a newsletter in 3 years. Myra charged Lanny and Lawson to put together a newsletter toe posted on the website quarterly. Lanny will assume primary responsibility for the newsletter. Malissa suggested using poster presentations from the meeting in the newsletter.
- It was noted that the Standing Rules do not define the tasks of the Communications Committee. Myra requested that the Publications and Communications Committee make a list of their activities and next year break into two separate committees with two separate chairs. Language will need to be developed to be placed in the Standing Rules to define committee responsibilities.

13. Membership

- Membership continues to trend down at a rate of approximately 6-10 per quarter.
- > Current membership is 33% of licensed RCPs in North Carolina.
- > There is currently some discrepancy between our membership numbers and those of the AARC. Ricky is working to get this clarified.
- > The AARC goal is to increase our membership by 10% and each director is charged with making 3 membership presentations to hospitals or educational programs during the year.
- > Human Resource rules prohibit mandating AARC membership.
- > AARC has the lowest dues of any healthcare organizations.
